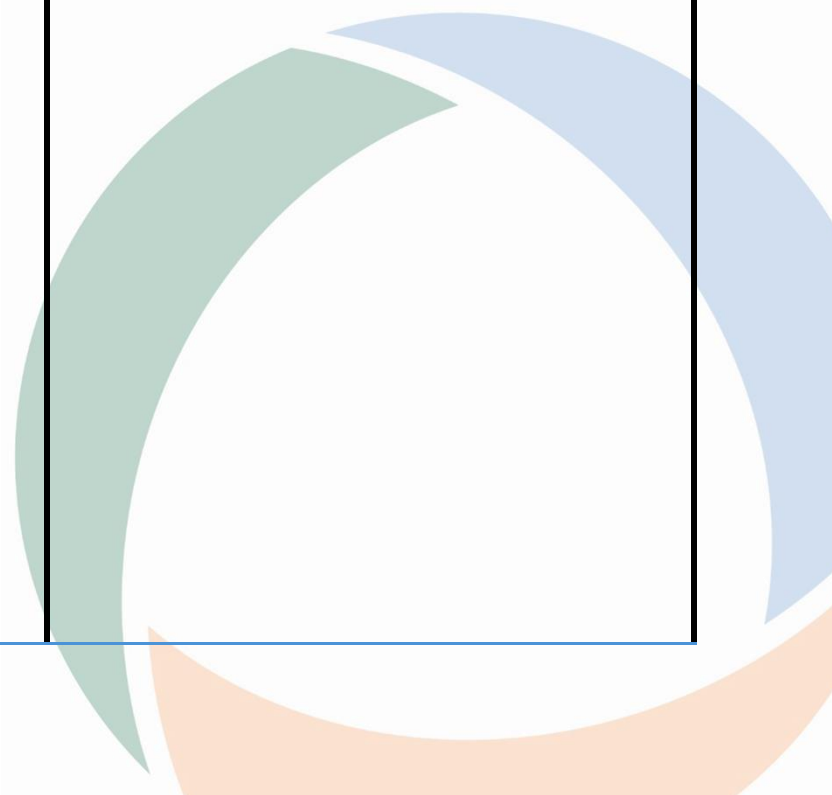


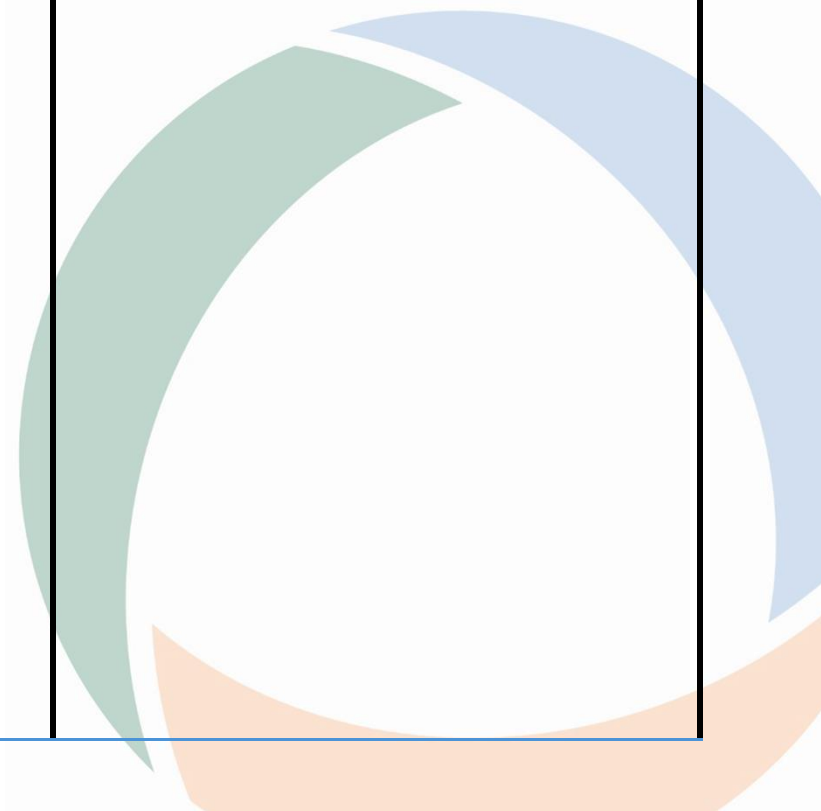

**What we spend & how we spend it:** Covering financial information relating to projected and actual income and expenditure and clear financial audit for transparency.
